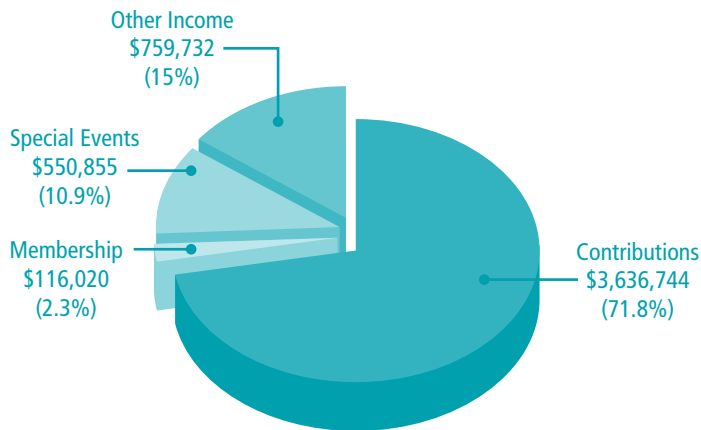
During 2006 Spina Bifida Association changed its year end from March 31 to December 31. As a result, the financial information presented is for the nine months ended December 31, 2006.

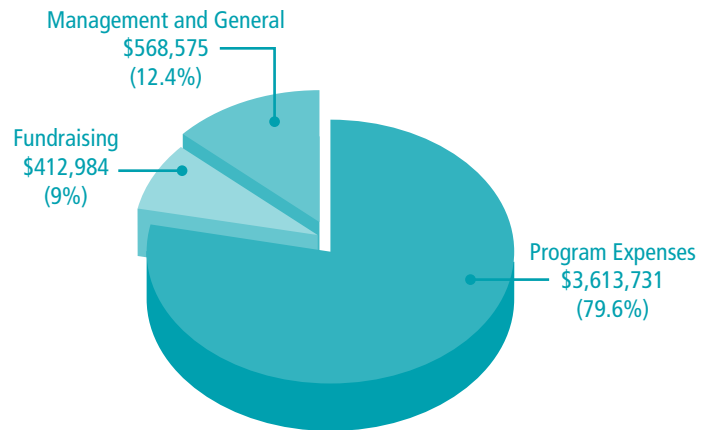
Revenues 2006
